

THE SPRINGHILL HOME OWNERS ASSOCIATION MET AT 1:00 P.M. AT THE GREEN ACRES LIBRARY ON NOVEMBER 4, 2006.

ROLL CALL WAS CALLED. ALL OFFICERS WERE PRESENT EXCEPT SCOTT HENDELSON WHO ARRIVED AT 1:20 P.M.

THE MINUTES OF THE PREVIOUS MEETING WERE READ AND ACCEPTED. CORRESPONDENCE FROM A HOME OWNER WAS ALSO READ.

THE TREASURERS REPORT WAS READ. THE BANK STATEMENT HAD NOT YET BEEN RECEIVED SO NO ABSOLUTE BALANCE WAS REPORTED. ABOUT 50 HOME OWNERS HAVE PAID THE \$200 ASSESMENT FEE AT THIS TIME.

THE VIOLATIONS REPORT REMAINED ABOUT THE SAME WITH COMMERCIAL VEHICLES AND UNKEMPT PROPERTIES.

OZZIE SCHELLING WAS ABSENT FOR THE LIGHTING COMMITTEE REPORT. A FIXTURE FOR THE FRONT ENTRANCE WOULD RUN ABOUT \$3700. IF THIS WERE TO WORK WELL ANOTHER WOULD BE INSTALLED AT THE OTHER ENTRANCE. MORE INVESTIGATION ON LIGHT IS BEING PURSUED.

THE JOG ROAD WALL COMMITTEE HEADED BY MARILYN FONG AT THE LAST MEETING WAS TO HAVE TWO MORE BIDS, BUT MARILYN FONG WAS ABSENT FROM THE MEETING. THIS WAS TABLED TO THE NEXT MEETING.

THE LAKE WORTH DRAINAGE RIGHT OF WAY COMMITTEE WAS HEADED BY MARIA PUENTAS. NO MORE INFORMATION WAS PRESENTED AS MARIA PUENTAS WAS ABSENT.
